Magic Access Acquisition Offer ("Offer") for LCSD's Museum Pass Terms & Conditions

- 1. The Offer is valid from September 1, 2024 to August 31, 2026 ("Promotion Period").
- 2. The Offer is only available to guests who are holders of any one type of valid Museum Passes ("Museum Pass") issued by the Leisure and Cultural Services Department of HKSAR Government ("Eligible Guests").
- 3. All Eligible Guests warrant that they have read these Terms and Conditions carefully. Each Eligible Guest signals his/her complete acceptance and full understanding of these Terms and Conditions by participating in this Offer. In the event of any dispute regarding these Terms and Conditions, conduct, results and all other matters relating to this Offer, the decision of Hongkong International Theme Parks Limited ("HKITP") shall be final.
- 4. HKITP reserves the right to disqualify any Eligible Guest if HKITP has reasonable grounds to believe that the Eligible Guest has breached any of these Terms and Conditions. HKITP may, at its discretion with or without cause, refuse to admit any person or persons to the Hong Kong Disneyland Park (the "Park") at any time.
- 5. Subject to these Terms and Conditions and availability, each Eligible Guest will be entitled to purchase one (1) Magic Access on the following applicable discount:
 - a) HK\$70 discount off the Published Price of any General Magic Access during the Promotion Period.
 - b) HK\$60 discount off the Published Price of any Child Magic Access during the Promotion Period.
 - c) HK\$60 discount off the Published Price of any Student Magic Access during the Promotion Period.
 - d) HK\$40 discount off the Published Price of any Senior Magic Access during the Promotion Period.

For the purposes of these Terms and Conditions, any Magic Access purchased under this Offer shall be referred to as "Discounted Magic Access"; and the price of Magic Access as published on the Hong Kong Disneyland website www.hongkongdisneyland.com (the "Website") shall be known as the "Published Price".

- 6. During the Promotion Period, each Eligible Guest may only purchase one Discounted Magic Access which will be personalized with details of the Eligible Guest. To participate in this Offer, each Eligible Guest is required to purchase his/her Discounted Magic Access personally, present his/her valid Museum Pass and such personal identification* and provide such personal data as HKITP may require at the time of purchase, have his/her photograph taken, and follow such procedures stipulated by HKITP. The name of the Eligible Guest, the same as on Museum Pass, will be printed on the Discounted Magic Access Personalized Membership Card and the name as printed cannot be changed. HKITP may refuse admission to the Park if in HKITP's determination the identity of the Eligible Guest cannot be verified by HKITP. If the Eligible Guest prefers not to have his/her photo retained by HKITP after it is taken, he/she may, before card issue, ask a cast member about alternative verification arrangement as HKITP may provide from time to time*.
 - * The photo identification must be valid and bears the full name and a recent photo of the guest. Types of acceptable photo identification may include:
 - (a) for General membership:
 - (i) Hong Kong residents: Hong Kong identity card or passport;
 - (ii) Non-Hong Kong residents: government-issued photo identification (such as passport, driver's license or PRC resident identity card).
 - (b) for Child membership: photo identification issued by a government or registered school (such as passport, Exit-Entry Permit, school handbook with official school stamp or student card).
 - (c) for Student membership: photo identification issued by a registered school (such as school handbook with official school stamps or student card) showing the guest's full-time student registration.

Example of alternative verification arrangement may include presenting such photo identification and provide such personal information as HKITP may require of the relevant guest(s) to our Cast Members upon card issue and each entry to the Park.

- 7. All guests are required to make reservation with valid tickets or membership cards before visiting the Park. Park visit reservation of each type of ticket or membership card is subject to a limited quota. Reservation will not be accepted once the respective quota is full.
