- (1) 有關《個人資料(私隱)條例》(第486章)的須知 Notes Regarding the Personal Data (Privacy) Ordinance (Cap. 486)
 - (a) 收集資料的目的 Purposes of Collection

經這份申請表填報的個人資料,將由發牌當局用於下列用途: The personal data provided by means of this form will be used by the Licensing Authority for the following purposes:

- (i) 處理向發牌當局申請簽發遊樂場所牌照的相關事宜:以及 carrying out activities relating to the applications for the grant of Places of Amusement Licence made to the Licensing Authority; and
- (ii) 方便發牌當局職員和其他政府部門的職員與申請人聯絡。 facilitating communication among staff of the Licensing Authority, other government departments and the applicant.

(2) 申請人須年滿十八歲。 The applicant should be aged 18 or above.

- (3) 申請遊樂場所牌照所需文件一覽表 Checklist of Documents Required for Application for Places of Amusement Licence
 - (a) 填妥的遊樂場所牌照申請表 A completed Application Form for Places of Amusement Licence
 - (b) 申請人的香港身份證或護照副本 A copy of the applicant's Hong Kong Identity Card / Passport
 - (c) 有關處所的最終設計圖則(圖則無須標示可移動家具,例如不固定安裝的枱及椅子)一式五份,圖則以十進制單位和不少於1:100的常用比例繪製,並清楚繪示該場所內須領牌的各部分。
 Five identical hard copies of the proposed layout plan of the premises (movable furniture, such as non-fixed tables and chairs, are not required to be shown in the plan), drawn in metric units and in scale commonly used of not less than 1:100, showing clearly the various parts of the place for which the licence is required.

In case that a ventilating system (including an air-conditioning system) is to be installed in the premises, the applicant is required to submit the ventilating system layout plans in triplicate, drawn as nearly as possible to scale.

(4) 按照《公眾衛生及市政條例》(第132章)第125(8)條的規定,若康樂及文化事務署署長決定拒絕申請人有關批出牌照的申請,必須以書面給予通知。假如申請人對署長的決定感到不滿,可根據該條例第125(9)條的規定,在宣布有關決定的通知書送達申請人後的14天內,向牌照上訴委員會提出上訴。Pursuant to Section 125(8) of the Public Health and Municipal Services Ordinance (Cap.132), the Director of Leisure and Cultural Services shall inform the applicant in writing of any decision made to reject the application for the grant of licence. If the applicant is dissatisfied with the decision made by the Director, he/she may within 14 days after the service on him/her of the notice declaring the decision appeal to the Licensing Appeals Board in accordance with Section 125(9) of the Ordinance
