RowKids Scheme - Joint Schools Rowing Training Programme

| Purpose | Provide continuous and systematic training for students with potential and aspiration to develop in rowing by enhancing their rowing skills. |
| Eligibility | (a) Participants should be able to swim 50 metres with clothes on; and (b) Participates should join in their own capacity, with recommendation from HKCRA's coach(es) to certify that the students have reached skill level of Star 3 or above. |
| Target Participants | Students of Primary 4 to 6 |
| Course Outline | (a) Stretching and warm-up exercises for rowing: Students will learn and fully master the stretching and warm-up exercises specifically for rowing. (b) Use of indoor rowing machines: Students will improve their rowing skills with the use of indoor rowing machines, and participate in the age group competition of indoor rowing. (c) Rowing skills: Students will learn to use advanced equipment (special boats for competitions), improve and even fully master the basic skills of rowing, and participate in the age group competition of rowing. (d) Small group activities: Learning will be in small groups. (e) Before the end of the course, the coach(es) will conduct a skill test for the students. Students who pass the test will have the opportunity to be selected by the HKCRA for further training. |
| Training Venue | Jockey Club Sha Tin Rowing Centre or Jockey Club Shek Mun Rowing Centre |
| Fee | \$710 per person |
| Duration | 32 hours per course (Can be divided into 16 sessions of 2 hours each according to activity arrangement. Students are advised to complete the training course within 2 consecutive months.) |
| Quota | 6 per group (A maximum of 2 training courses for each student in the same school year) |
| Proposed Time of Activity | Monday to Friday: 4 pm to 6 pm or Saturday and Sunday: 9 am to 6 pm |

| Notes of Enrolment | <p>(a) The applicant should apply in his/her own capacity and have the enrolment form stamped by the school.</p> <p>(b) The rowing training course will be conducted at the Sha Tin Rowing Centre or Jockey Club Shek Mun Rowing Centre under the HKCRA. The practice date and time will be arranged by the HKCRA or co-ordinated with the students. If you have enquiries about the activity date, please contact the staff of the HKCRA (Tel: 2696 2337 or 3841 7351).</p> <p>(c) Students must submit the applications, each with a recommendation letter from the coach (in the lower part of the enrolment form) and a cheque of the relevant amount (made payable to "Hong Kong, China Rowing Association"), by post to the office of the Hong Kong, China Rowing Association, Jockey Club Sha Tin Rowing Centre, No. 27 Yuen Wo Road, Sha Tin N.T. one and a half months before the commencement of the activity. Please mark "RowKids Scheme - Joint Schools Rowing Training Programme" on the envelope.</p> <p>(d) The organiser reserves the right to cancel the course in case of insufficient enrolment.</p> <p>(e) The activity will be cancelled in the event of school suspension announced by the Education Bureau or the following severe weather conditions:</p> <p>(1) The Observatory issues the Strong Monsoon Warning Signal, Thunderstorm Warning, Tropical Cyclone Warning Signal No. 1 or above, or Amber Rainstorm Warning Signal or above two hours before the activity; or</p> <p>(2) If the Environmental Protection Department announces that the Air Quality Health Index recorded by general stations reaches the "serious" level (i.e. 10+), outdoor activities in the affected areas must be stopped immediately.</p> <p>(f) There is no refund for all cancelled classes. Subject to the availability of the venue, the HKCRA will arrange make-up lessons as far as possible.</p> |
